


5.1.4 The application forms for Fellowship, Full, Corresponding and Institutional Memberships must be supported by the recommendations of two Fellows or two Full Members of the Society, while those for Student Membership by the recommendation of one Fellow or one Full Member of the Society. Upon approval of the application by the Executive Committee and the payment of the prescribed fees as stipulated in 5.2, the applicant shall become a Fellow, a Full Member, a Student Member, a Corresponding Member or an Institutional Member, as the case may be.


